Soldering Profile

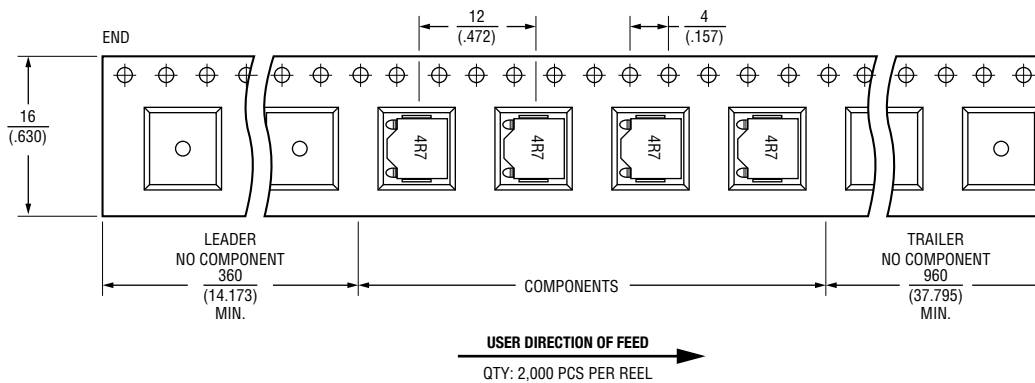
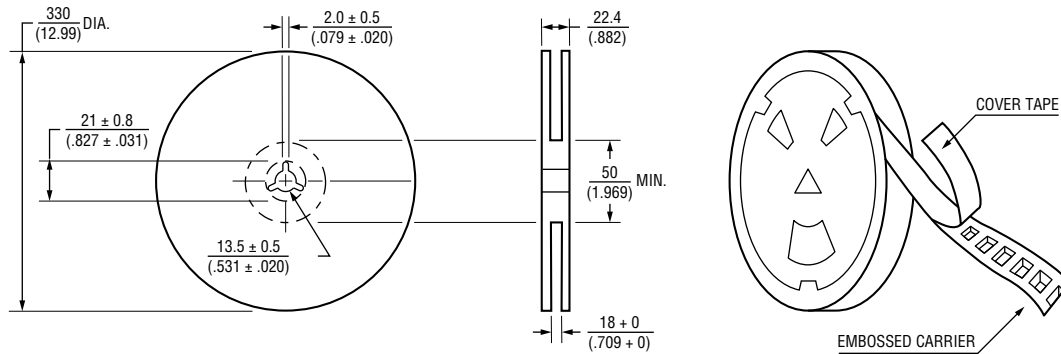
